Eye products of all types (eye shadow, mascara, eyeliner, eye make-up, etc...). Women's make-up (Foundation). Make-up removers of all types. Nose pore strips. Wipes or refreshing tissues for face, neck, hands, body paint (for children and adults). Facial masks (facial treatment)

CLASSE 4 : 48.57%

Hydroalcoholic and non-hydroalcoholic fine fragrance of all types (Eau de toilette, Parfum, Eau de Cologne, solid perfume, fragrancing cream, Aftershave alcoholic etc...). Fragranced bracelets. Ingredients of perfume kits and fragrance mixtures for cosmetic kits. Scent pads, Foil packs. Scent strips for hydroalcoholic products

CLASSE 5A : 12.29%

Body creams, oils, lotions of all types (except baby cream, lotion, oil). Foot care products (creams & powders). Insect repellent intended to be applied on the skin. All powders and talcs (except baby powders and talcs)

Facial creams, toner and moisturizers

Hand cream. Nail care products (including cuticle creams, etc...). Hand sanitizers

CLASSE 6* : 0.07%

Mouthwash including breath sprays, tablets and strips.Toothpaste and toothpowder

CLASSE 7A : 1.49%

Rinse-off hair permanent or other hair chemical treatments (e.g. relaxers) including hair dyes

CLASSE 7B : 1.49%

Hair sprays.Hair styling aids of all types (mousse, gels, leave in conditioners).Dry shampoo or waterless shampoo.Hair deodorant.

Leave on hair permanent or other hair chemical treatments (e.g. relaxers) including hair dyes

CLASSE 8 : 0.37%

Intimate wipes.Tampons.Baby wipes.Wet toilet paper

Air delivery systems.Air Fresheners and fragrancing of all types (excluding aerosols listed in category 10), e.g. plug-ins and enclosed liquid refills, solid substrate, membrane delivery, electrical, powders, fragrancing sachets, incense, air freshening crystals, automated sprays (including concentrated aerosols with metered doses [range 0.05-0.5 mL/spray]), closed air fresheners.Candles of all types (including
