Mouthwash including breath sprays, tablets and strips. Toothpaste and toothpowder

Rinse-off hair permanent or other hair chemical treatments (e.g. relaxers) including hair dyes

**CLASSE 7B : 2.67%**

Hair sprays. Hair styling aids of all types (mousse, gels, leave in conditioners). Dry shampoo or waterless shampoo. Hair deodorant.

Leave on hair permanent or other hair chemical treatments (e.g. relaxers) including hair dyes

**CLASSE 8 : 1.13%**

Intimate wipes. Tampons. Baby wipes. Wet toilet paper

Other household cleaning products (fabric cleaners, soft surface cleaners, carpet cleaners, furniture polishes (sprays and wipes), leather cleaning wipes, starch sprays, stain removers, fabric enhancing sprays, treatment products for textiles including deodorizer). Tights with moisturizers. Scented socks, gloves. Facial tissues (dry tissues). Napkins. Paper towels. Wheat bags. Fragranced face masks (paper/protective, not intended for use as a medical device)

Air delivery systems. Air Fresheners and fragrancing of all types (excluding aerosols listed in category 10), e.g. plug-ins and enclosed liquid refills, solid substrate, membrane delivery, electrical, powders, fragrancing sachets, incense, air freshening crystals, automated sprays (including concentrated aerosols with metered doses [range 0.05-0.5 mL/spray]), closed air fresheners.
