Eye products of all types (eye shadow, mascara, eyeliner, eye make-up, etc...). Women's make-up (Foundation). Make-up removers of all types. Nose pore strips. Wipes or refreshing tissues for face, neck, hands, body paint (for children and adults). Facial masks (facial treatment)

**CLASSE 4 : 59.99%**

Hydroalcoholic and non-hydroalcoholic fine fragrance of all types (Eau de toilette, Parfum, Eau de Cologne, solid perfume, fragrancing cream, Aftershave alcoholic etc...). Fragranced bracelets.
